

**Minutes of the Annual Parish Meeting of Yeovilton held on May 9th 2017

Apologies

Apologies were received from Mr. A. Capozzoli, District Councillor, Rev. B Faulkner & PCSO John Winfield.

The Minutes of the Annual Open Parish meeting held on May 10th 2016, having been circulated, and copies available, for the public, were signed as correct.

The Chairman welcomed all present.

Mrs. Jones gave her report, which included that it had been an interesting year, with the Podimore Shooting School at Higher Farm, Podimore application being granted on appeal, this to extend the hours of shooting to include Saturdays & Sundays, with now defined hours.

An application for new build in Yeovilton village caused controversy amongst Councillors and was withdrawn. Pre-application drawings were shown to meetings of the Council, for two sites, one at Manor Farm, Yeovilton and the other one at Podimore. To date no formal applications have been received.

The saga reference the drainage issues at Stockwich Cross roads to Bridgehampton are still ongoing, as fuel contamination has been accepted, but exploratory work has been abandoned. The drainage issue at the end of Church Street, Podimore is still ongoing. The Council are pressing for action in both cases.

The second application for the construction of a Waste Transfer Station at RNAS Yeovilton in the Stockwich Cross area is under consideration by SCC.

Mrs. Jones thanked all her fellow Councillors for their support during the past year, Mr. Browncey, elected vice Chairman, and Mr. Elliott who joined the Council, following the resignation of Mr. D. Amlot due to work relocation.

Mrs. W. Scrivener was thanked for acting as Internal auditor, also the Clerk for his input, including the work in setting up the Website.

Mrs Jones congratulated Mr. M. Lewis, on being re-elected County Councillor, and thanked him & Mr. A. Capozzoli, District Councillor, for their support during the year, and attendance at the Council's meetings.

The Councillors thanked the Chairman for her work for the Council throughout the past year.

RNAS matters

Commander B. O'Sullivan reported that Commodore Nick Tindall is the new Commodore and Commander Dave Wilson has been appointed Community Relations Officer taking up his role on June 2nd. Air Day will be held on July 8th.

County & District Councillors' reports

In the absence of Mr. Capozzoli, District Councillor, who was attending the Parish meeting of Limington Parish, there were no issues reported from County or District Councils.

There being no further business, the Chairman thanked all for their attendance and declared the meeting closed at 7.45pm.
