

**Minutes of the Annual Parish Meeting of Yeovilton held on May 8th 2018
at St. Bartholomew's Church, Yeovilton at 7.30pm.**

Apologies

Apologies were received from Rev. B Faulkner & PCSO John Winfield.

The Minutes of the Annual Open Parish meeting held on May 9th 2017, having been circulated, and copies available, for the public, were signed as correct.

The Chairman welcomed all present.

Mrs. Jones gave her report, which included that it had been a year, with very little action in resolving the drainage issues at Stockwich Cross roads to Bridgehampton, and the drainage issue at the end of Church Street, Podimore is still ongoing, it being very disappointing as the works' Order was published to start in April, only to be now deferred now until the Autumn.

A planning application for a dwelling in Weir Lane, Yeovilton was granted at SSDC Area East Committee, despite opposition from the adjacent residents and the Parish Council, being the first permission granted for ten years.

The Council still are pressing for a 40 MPH Speed limit on the B.3151 from Ilchester to RNAS Yeovilton, this being highlighted as necessary, due to a tragic fatality during the past year. There is an indication that there may be action soon.

Mrs. Jones reported that the Podimore Shoot is settling into their allocated days & times to shoot.

Reference the application drawings shown to the Council, reported last year, for two sites, one at Manor Farm, Yeovilton, to which no application has been received. Permission was granted for the site at Podimore.

There is no decision to date for the construction of a Waste Transfer Station at RNAS Yeovilton in the Stockwich Cross area by SCC.

Mrs. Jones thanked all her fellow Councillors for their support during the past year, Mr. Browncey, vice Chairman, all members, and the Clerk.

Mrs. W. Scrivener in her absence, was thanked for acting as Internal auditor.

Mrs Jones thanked both Mr. M. Lewis, County Councillor, & Mr. A. Capozzoli, District Councillor, for their support during the year, and attendance at the Council's meetings. Mrs. Jones thanked Mr. R. Graydon CRO, RNAS for his support and taking on this role, during the year.

There were no other reports.

The Councillors thanked the Chairman for her work for the Council throughout the past year.

RNAS matters

Mr. Graydon, CRO stated that the tragic incident on the B.3151 & the incident in Ilchester were very much to be regretted, and the law was taking its course.

Mr. Graydon stated that RNAS fully support the request for a speed reduction on the B.3151, and he is in discussions reference the drainage issues at Stockwich Cross area.

County & District Councillors' reports

Mr. Capozzoli, District Councillor, gave his report, which included that SSDC had granted permission for a digester at New Spittles, Farm, Ilchester, and SSDC are considering investing in three Electric Charging points for cars, one being at the Limington Road car park, Ilchester.

Mr. D. Board expressed his concerns at the impact of having Digesters within the area on farming rental values.

Mr. M. Lewis, County Councillor thanked the Chair and members for their support during the past year.

Mr. Lewis stated that SSDC were obliged to approve the Digester plant, on which there could be conditions, else it would have been lost on appeal.

There being no further business, the Chairman thanked all for their attendance and declared the meeting closed at 8.00pm.
